

ENFORCEMENT

EXAM RESULTS

The ASBOG® exam was last given in October of 2005. Of the 33 candidates who took the Fundamentals of Geology, 17 received passing scores. Of the 19 who took the Practice of Geology, 10 received passing scores.

The ASBOG® exam will be given again in Austin, Texas on March 3, 2006.

Enforcement activities at the TBPG have commenced. One aspect of this enforcement activity consists of reviewing reports submitted to various Texas agencies. Agencies visited include the Texas Water Development Board, the Railroad Commission of Texas, the Texas Commission on Environmental Quality (TCEQ), and the Department Texas Transportation. The purpose of this compliance activity is to ensure that maps and figures in these reports are submitted with the proper P.G. seal(s) and to also ensure that people signing the reports are licensed in Texas. Another purpose of this enforcement activity is to make that geoscience certain work is not being performed by non-licensees or expired licensees. This compliance activity will continue at these agencies

for the foreseeable future.

Future plans for enforcement will include visiting other State agencies and programs within these agencies to review reports that contain geoscience information. For example, investigation efforts at the TCEQ have currently focused on the Voluntary Cleanup Program. Other programs to be investigated at the TCEQ will include the Corrective Action Program, Leaking Petroleum Storage Tank Program, and the Municipal Solid Waste Program.

Other aspects of enforcement include responding to formal complaints received by the Texas Board of Professional Geoscientists (TBPG). These complaints will include, but are not limited to, instances involving behavior

harmful to the safety of public health and welfare or that involve violations of the Texas Geoscience Practice Act. It is imperative that the general public inform the TBPG if such instances occur so that an investigation can commence immediately.

Notices of Violation(s) (NOV) concerning the use of the P.G. seal will be mailed out to individuals deemed to be in violation of the sealing requirements of our rules. If you receive an NOV, you must respond in the timeframe prescribed in the The corrected letter. document(s) should resubmitted to the agency where the report was originally submitted, and a copy of the corrected document(s) should be forwarded to our office.

CONTINUING EDUCATION

The Continuing Education Program for TBPG licensees will become effective September 1, 2006. All licensees renewing after that date will be required to submit proof of their continuing education hours upon renewal if requrested.

Booklets outlining the CE Program will be sent out to all licensees in the coming weeks. Included in the booklet will be a log sheet to assist in tracking CE hours.

Random audits will be conducted as part enforcement, and upon request additional proof of CE hours must be provided.

FIRM REGISTRATION

At the November 17, 2005 Board meeting, the Board approved rule §851.30 for the registering of firms to practice geoscience before the public in Texas. The rule would apply to all corporations, joint stock associations, partnerships and sole proprietorships. The rule will be up for adoption at the March 17, 2006 Board meeting if after the public comment period and any public meet-

ings held, there are no significant changes made to the rule.

The fee for firm registration was also approved at the November meeting and it is set at \$75, with an annual renewal fee of \$150. However, the Board may discuss a reduced fee for sole proprietorships at the next Board meeting in March.
