

# Letter from the Acting Executive Director

In July, 2006, LTC Michael Hess, Executive Director, was re-activated to the United States Army and has since been stationed in Iraq. In the interim, I have been filling in at the request and approval of the Board. I have been employed by the State of Texas for more than 20 years, and have been with TBPG since September 1, 2003. I was hired as the Agency's Chief Financial Officer, was later promoted to Deputy Executive Director, and now am currently the Acting Executive Director.

Enforcement continues to be our main focus. TBPG has been busy investigating some complaints regarding work performed by unlicensed geoscientists, and also has been busy with the outreach effort.

Beginning September 1, 2006, Continuing Education and Firm

Registration became effective. To date, approximately 200 licensees have had an audit conducted on the PDH's they have claimed and we have registered approximately 130 firms.

The 80th Legislative Session began January 9, 2007. TBPG presented testimony to the Senate and House Appropriations Committee regarding our budget request for funding for the 2008-09 biennium.

Our office was audited by the State Office of Risk Management. After successful completion, TBPG was awarded the Sustained Safety Performance Award for the second year in a row. Congratulations to our staff for all of their hard work!

# Message from the New Chairman

What an extraordinary privilege and honor – Chairman of the Board for the greatest profession of the greatest State in the greatest country ever! And... (whew!)... what a responsibility. We now have approximately 6,500 licensed Professional Geoscientists among a Texas population that has moved north of 23,000,000. That's more than 3,500 of the public for each PG. By comparison, there are over 32,000 Texas PEs, one for approximately every 700 of the public. How many attorneys? Dunno, but lots. (So hard to get a straight answer...) Google sites show one lawyer for every 200 Texans.

As usual and as always, geoscience impacts society *far* beyond what our numbers might suggest. Things were simpler when I was six. Playing in the dirt with my T. Rex and Brontosaur (before a mysterious Al-Qaeda conspiracy renamed them Apatosaurs) and confusing grownups by telling them I wanted to be a paleontologist were the best parts of my day.

# Adopted Rule Update

On November 17, 2006, the Board adopted an amendment to TAC 22 §851.30, Firm Registration. This amendment requires all firms that engage or offer to engage in the public practice of geoscience in Texas be registered with TBPG. This rule applies to all firms including corporations, sole-proprietorships, partnerships and/or joint stock associations unless the firm is an engineering firm that performs service or work that is both engineering and geoscience. The amendment also allows those firms who meet any of the exemptions under §1002.252 of the Act to be exempt from registering their firm. In conjunction with this rule, 22 TAC §851.152, Firm Compliance was amended in August, 2006. The amendment further outlines the requirements, restrictions and responsibilities of a firm in regards to the Firm Registration Rule.

Licensees can assist with this effort by

encouraging their firms to register. Registration forms can be found on our website.

Also adopted was an amendment to §851.32 Continuing Education. The amendment to this rule removed language regarding a licensee's ability to claim an inactive status as the inactive license status is not supported by TBPG's governing statute.

The adoptions were posted to the Texas Register on November 29, 2006 and became effective 20 days after posting. They can be found in the December 15, 2006 issue of the Texas Register or on our website.

# Continuing Education

As of September 1, 2006, it is required that all renewing licensees complete 15 Professional Developmental Hours (PDHs) of Continuing Education (CE) before renewing (for a list of acceptable activities and the limit on PDHs that can be claimed for each, please read Rule §851.32 on our website). Licensees will be asked to certify that they have fulfilled this requirement at the time of renewal, whether renewing manually or online. The renewal process cannot be completed until the licensee has satisfactorily met the Continuing Education requirement. If a renewal form is received on which the licensee has indicated that the CE requirement has not been met, the license will not be renewed until the licensee supplies evidence of having fulfilled the requirement. It is advised that renewals not be submitted until the requirement has been met, as fees

are non-refundable per §851.28 of our rules.

Random audits will be conducted of approximately 10% of licensees. A letter is sent to randomly-selected renewing licensees requesting that the licensee's Continuing Education Program Activity Log and supporting documentation be returned to the TBPG office. After reviewing the submitted materials, a letter will be returned to the licensee indicating a successful satisfaction of the requirements, or requesting more information or further clarification of claimed activities.

#### **EXAM RESULTS**

#### October 6, 2006:

Of the 32 candidates that took the Fundamentals of Geology portion, 17 achieved a passing score. Of the 23 candidates that took the Practice of Geology portion, 18 achieved a passing score.

### March 2, 2007:

Of the 47 candidates that took the Fundamentals of Geology portion, 24 achieved a passing score. Of the 27 candidates that took the Practice of Geology portion, 17 achieved a passing score.

# From the Enforcement Office

Audit of reports at the Texas Commission on Environmental Quality (TCEQ) continues. Specifically, review of LPST files is taking place to look for violations concerning the use of the PG seal. As per 851.156(j) of the Act "The geoscientist shall sign, seal and date the original title sheet of bound geoscience reports, specifications, details, calculations, estimates, and each original sheet of plans or drawings regardless of size or binding." Another aspect of reports review at the TCEQ is to discover if licensees are practicing with an expired license.

Letters requesting PG seal samples are still being mailed to licensees. As per §1002.263 of the Act and §851.20(m) of the rules, license holders must obtain a seal of a design established by the Board and returned to our office. Failure to respond in a timely manner to official Board inquiry as per §1002.263 of the Act and §851.155 of the rules will result in an administrative penalty of \$100. If you are unsure if you have submitted your PG seal or if you have submitted a seal sample and want to ensure that it is on file, please contact Mr. Alberto Jimenez, P.G. at 512-936-4406 or aiimenez@tbpg.state.tx.us

Digital seals are acceptable to the Board and can be made via the TBPG website. Once there, click on the caption "Creating a digital seal" and follow the instructions. When completed, send the seal via email or by fax to the TBPG offices.

It is incumbent upon licensees and the general public to report conduct and matters that are potentially detrimental to the welfare and safety of the public. The first step in reporting a possible enforcement matter is to submit a written complaint (a complaint form can be downloaded from our website). Complaints cannot be anonymous.
