## P.G. Seal Submission Form

It is required that all Professional Geoscientists have a professional P.G. seal on file with the Board, as required by §1002.263 of the Texas Geoscience Practice Act and TBPG Rules Section §851.20(q).

**Sec. 1002.263. SEAL.** (a) On issuance of a license, the license holder must obtain a seal of a design established by the board bearing:

- 1) The license holder's name;
- 2) The license number;
- 3) The words "Licensed Professional Geoscientist;" and
- 4) The license holder's discipline of geoscience.

(b) A geoscientific report, document, or other record, as defined by the board, that is offered to the public and prepared or issued by or under the supervision of a licensed geoscientist must, in accordance with rules adopted by the board, include the full name, signature, and license number of the license holder who prepared the report, document, or other record or under whose supervision it was prepared and bear an impression of the license holder's seal.

**TBPG Rule 851.20(q).** Once the requirements for licensure have been satisfied and the new license and certificate have been issued, within sixty (60) days of notification the new licensee must then:

- 1) Obtain a seal and submit TBPG Seal Submission (Form X) to the TBPG;
- 2) Register as a Geoscience Firm, if appropriate, as described in §851.30 of this chapter.

Every licensee should be familiar with and follow the specific sealing requirements in Board rule §851.156.

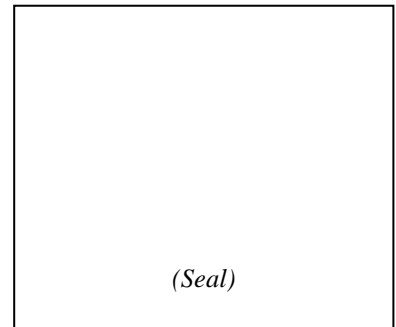
