Section §57.491: Loan Default Ground for Nonrenewal of Professional or Occupational License published in the Texas Register. The Committee unanimously moved to recommend the proposed new rule as published in the Texas Register to the full Board for adoption.
- F. Regarding the proposed new rule Section 22 TAC 851.155 regarding Family Code Chapter 232: Suspension of License. Section §232.003 published in the Texas Register.
