#### **MINUTES**

- A. The meeting of the Texas Board of Professional Geoscientists was called to order at 8:38 a.m. Roll was called, and a quorum was certified. Members present were Board Chairman C. Thomas Hallmark, PhD, PG, and Members W. David Prescott, II, PG, Vice-Chairman, Lindsey Lee Bradford, Steven Fleming, PG, and Christopher Mathewson, PhD, PG, PE. Member Bereket Derie, PhD, PG, arrived at 8:55 a.m. Members Becky Johnson, PG, Secretary/Treasurer, and Greg Ulmer, JD, were not present.
- B. The minutes from the February 24, 2017 Board Meeting were approved unanimously.
- C. Public comment. No members of the public were present.
- D. Chairman's Report: Dr. Hallmark addressed TBPG's upcoming activities related to Sunset review.
- E. Executive Director's Report: Mr. Charles Horton addressed fiscal and budgetary matters; use of staff resources; 85<sup>th</sup> Texas Legislative session; update on TBPG's appropriations process; and review of filed bills potentially affecting TBPG.
- F. Reports on recent Committee meetings and activities.
  - 1. The Application Review and Continuing Education Committee Report (4/27/17), given by Committee Chair David Prescott, addressed the development of consumer information/agency publications for general distribution.
  - 2. The Compliance and Enforcement Committee Report (4/27/17) was addressed by Dr. Hallmark. The Committee's items will be covered later on the agenda.
  - 3. The General Issues Committee Report (4/27/17), given by Committee Chair Christopher Mathewson, addressed recent activities related to facilitating communication with TDLR and the water well driller program regarding the review of statute and rules allowing geoscientists to use power equipment for extraction of soil and geologic samples and placement of piezometers.
  - 4. The Financial Review and Strategic Planning Committee had not met; no report was given.

#### G. Staff Reports:

- 1. Licensing Report. Ms. Elsa Paynes, Licensing Coordinator, reported on current licensing data, and ASBOG® examination statistics from the March exams. Ms. Molly Roman, Operations Manager, updated the Board on recent efforts to enter into reciprocity agreements with other jurisdictions.
- 2. Financial Report. Ms. Lisa Stockton, Chief Financial Officer, mentioned revenues, expenditures, travel updates, and identification badges for Board members.
- 3. Enforcement Report. Mr. T. Wesley McCoy, PG, Enforcement Coordinator, communicated current enforcement numbers, recent Complaint Review Team (CRT) meeting highlights, outreach opportunities, staff dismissal of complaints, and cases due to be heard at SOAH.
- H. Applications for P.G. license received from the following individual:

- a. Daniel Smith: Applicant for P.G. license requesting a waiver of the ASBOG® Fundamentals of Geology and ASBOG® Practice of Geology examinations. The Board unanimously approved Mr. Smith's request for waiver of the Fundamentals examination in a vote of 6-0; The Board also unanimously approved his request for waiver of the Practice examination in a vote of 6-0.
