The Chairman's Column



An Update On The New Advisory Committees for TBPG.....

The board has been hard at work developing our procedures to form advisory committees that will help us with specific issues. At the last meeting, the Board approved the process and authorized the staff to begin recruiting for these new advisory committees. Our goal for these advisory committees (ACs) is to have you, the regulated community, get more involved with TBPG and help us in setting the direction for the next few years. So, how are these ACs going to work? Let me try to explain:

The Board has four permanent committees (Board committees, or BCs):

1. General Issues
2. Compliance & Enforcement
3. Application Review & Continuing Education
4. Financial Review/Strategic planning

When an issue comes to light, the board and staff must first decide which of the four Board committees will take primarily responsibility for addressing that issue. Usually, the Board committee and staff do the research, develop recommendations and/or regulations, and present a final recommendation to the board for a board vote.

With the addition of ACs for certain issues, the process will look like this: the Board committee will determine the need for an AC and develop a "charge" or goal for the AC, the desired size of the AC, a set of desirable qualifications for AC members, and a timeline for completion of the work. The staff then search the database of licensees/firms, and match them with the desired qualifications. The staff will randomly generate requests to serve, process the responses received, verify the qualifications, and notify the AC committee members of their selection to serve. The AC is given the charge and asked to work on the issue, ultimately providing a recommendation to the Board Committee, who

would then decide when to bring it to the full Board for a vote. At that point, that specific AC ends because the issue has been addressed (unless the full Board sends it back to committee for additional research).

Our hope is that the addition of ACs will provide opportunities for more of our community to be involved in the decision-making process and to have more contact with the Board itself. Since the commitment to an AC is short-term, we hope that you will respond positively when you receive a request to serve, and perhaps, more importantly, that you might reach out first and tell us of your desire to participate with these ACs!

This is your call to action – reach out and tell us you want to serve on an AC or perhaps put your name on a list to be a subject matter expert (SME) for us! See contact information below.

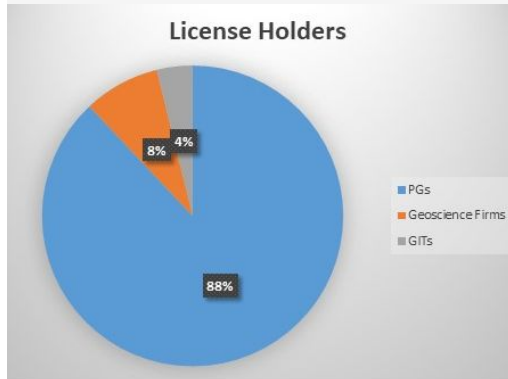

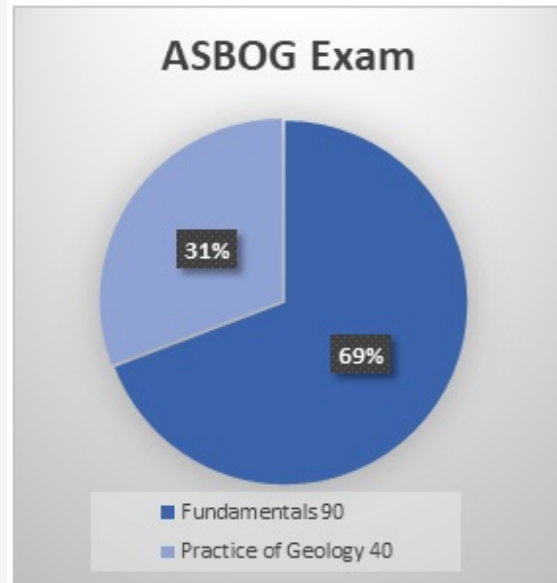

Highlights from the August 23, 2019 Board Meeting

Waiver Request. One application for P.G. license was unanimously approved for waiver of the Fundamentals examination contingent upon verification of 15 years qualifying work experience.

Adoption of amendments. The Board unanimously adopted amendments to 22 TAC 851.20, 851.22, 851.23, 851.40, 851.41, and repeal of 851.24. These adoptions allow TBPG to be in compliance with statutory changes in the Texas Geoscience Practice Act. These adoptions are in the process of being filed with the Texas Register.

Agreed Board Orders. The Board unanimously adopted Agreed Board Orders for Complaints 2019002 and 2019003, with Board Members Brandon Stowers and Steven Fleming being recused.

Formation of Advisory Committees. The Board unanimously granted authority to form Advisory Committees, regarding the identification of potential licensing opportunities and firm registration.
