#### 88th Texas Legislative Session...

Since January, we have had the opportunity to meet with many legislative offices to provide information about our Agency. This has been a great opportunity to 'tell our story' in terms of who we are, what we do, and the important role our Agency and our licensees have in protecting the environment and the public. We already had the opportunity to present our Legislative Appropriation Request (LAR) for the upcoming biennium (2024-2025) to the Senate Finance and House Appropriations Committees and are pleased with the positive comments received about our Agency and the importance of our licensees in this State. TBPG will continue to monitor and respond to proposed legislation until the 88th Texas Legislative Regular Session adjourns on May 29th, 2023.

#### **Computer-Based Testing...**


TBPG is excited to be a part of the nationwide launch of the Association of State Boards of

Geology (ASBOG) computer-based testing. While there are many benefits to this new testing model, we are most excited about the exams being offered in 40+ locations across Texas - and we look forward to seeing this number grow. This change creates more geographic access to the required examinations while eliminating the time and expense of traveling to a single location in Austin. This change also modernizes the examination format from a pencil and paper exam to a computer-based examination. As with any new program, we expect there will be a learning curve and areas identified for improvement but we will continue to work closely with ASBOG and recommend any necessary adjustments to provide the best examination program and experience for our licensing candidates.

## **ASBOG Spring 2023 Computer-Based Examinations**

The first computer-based administration of the ASBOG Fundamentals of Geology (FG) and Practice of Geology (PG) examinations is scheduled for March 16 & 17, 2023. Although TBPG is no longer administering the exam(s), we will continue to qualify applicants to sit for examinations and distribute exam scores to candidates.

The fall examination is scheduled for October 6th, 2023.

#### New 2023 ASBOG Examinee Candidate Handbook

The ASBOG Examinee Candidate Handbook is the official guide to policies and procedures for the ASBOG National Geology Examinations. This guide will provide important information to exam candidates regarding scope; content and development of the licensure exams; a step-by-step guide to register and pay for the computer-based exams and select a testing location; and example practice questions to help prepare for the ASBOG National Geology Examinations.



# Highlights from the February 10, 2022 Board Meeting

# **Requests For Waiver of Examination**

The Application Review Committee considered 8 applications for waivers, and

recommended 7 of them to the Board.

The full Board approved all 7 of the waiver requests as recommended by Committee.

## **Proposed Agreed Board Orders**

Proposed Agreed Board Orders are disciplinary orders that are proposed by TBPG's Complaint Review Team and, subsequently, agreed to by the Respondent of a Complaint.

Two Proposed Agreed Board Orders were on the agenda

Proposed Agreed Board Order for Complaint 2023-00017. No action was taken.

Proposed Agreed Board Order for Complaint 2020-00007. No action was taken.

### **Proposed Amendments**

Proposed Amendment to 22 TAC 851.43; GIT Certification Period and Renewal The current rule allows for GITs to renew their certification yearly for up to eight years, and requires renewals past the eighth year to be granted at the discretion of the appointed Board. The proposed amendment allows for a GIT to be renewed indefinitely without requiring action by the Appointed Board when all other renewal requirements are met.

• The Board unanimously approved this proposed amendment for posting to the Texas Register for public comments.

Proposed Amendment to 22 TAC 851.10; Definitions Adds the term "Digital Signature" to the definitions.

• The Board unanimously approved this proposed amendment for posting to the Texas Register for public comments.

Proposed Amendment to 22 TAC 851.156; Professional Geoscientist Seals
The TBPG recently received public comment asking that the Board clarify
its rules on digital signatures. Upon review, the Board determined it
necessary to include provisions in the rules defining and allowing
licensees to use digital signatures to satisfy the signature requirements
for electronic geoscience documents.

• The Board unanimously approved this proposed amendment for posting to the Texas Register for public comments.

#### **Adopted Amendments**

There were no amendments for adoption on the agenda.


