This quarterly publication helps us keep you updated on current information related to our agency so I want to thank everyone, including those licensees who agree to be highlighted in our "P.G. in the Spotlight" section, who play an important part in delivering this update to you every 3 months. As you may know, the 89th Regular Session of the Texas Legislature recently concluded its business on June 2nd. While the Legislature considers many different bills during each legislative session, the State budget is the only bill that they are constitutionally required to pass. During this session, our agency provided testimony on our Legislative Appropriations Request for Fiscal Years 2026-2027 (biennium) in front of the Senate Finance and House Appropriations Committees. While many agencies go into the budget process seeking considerable additional funding, we were proud to provide a request that maintained our same baseline budget amount in FY2026 that we were provided during the previous two years along with the ability to add one additional position in FY2027 if needed. We are thankful to the legislature for recognizing our efforts to consistently operate in a fiscally responsible manner and approving our budget as submitted. Operating within our same budgeted amount over multiple years as we have continued to do is always challenging but I am proud of our team for everything they do to seek efficiencies in carrying out our daily operations while always providing quality/responsive service to our customers.

On behalf of our office team and our appointed Board, I would like to also recognize our certified Geoscientists in Training, licensed Professional Geoscientists, and registered

Firms for your continued partnership in protecting public health and safety. We hope you have a safe and successful summer season!

ARTICLE FROM THE TBPG VAULT!

Failing to Seal Geoscience Work by Becky Johnson, P.G.

TBPG has seen a significant increase in the amount of unsealed public work, and we want to make sure that licensees are aware of the sealing requirements and avoid violations. Many of our recent complaints have stemmed from the mistaken idea that "if work is not submitted to a government agency, it doesn't have to be sealed." Nothing could be further from the truth. The rules are clear - any final work product that involves geoscience MUST be sealed. (See 851.156(k-I)) Many of our recent violations involve Phase II Environmental Site Assessments.

While the TBPG has determined that a Phase I ESA does not require a seal, Phase II and Phase III work do. (See Enforcement FAQs). A number of our interactions involve licensees that sign and seal Phase IIs going to TCEQ, but don't sign and the seal Phase IIs that are "only going to a client." Some call this an "internal" document - let me be clear - THIS IS NOT AN INTERNAL DOCUMENT AND MUST BE SEALED. Performing a Phase II (or any other non-exempt work) for a client constitutes performing geoscience for the public and is subject to regulation regardless of whether this work is submitted to a regulatory agency or sealed. (See 851.156(k)). Lastly, we have had several licensees state that they are "stingy" or "cautious" with their seals and they "don't seal just anything," instead only sealing work submitted to a regulatory agency. While we appreciate PGs taking their sealing duties seriously, being "careful" should not cause you to violate the sealing rules. Rather, a PG's caution and care should result in quality work that is worthy of your seal.



We are pleased to introduce our P.G. In The Spotlight: Rebecca Owens, PhD, P.G. #15691



Dr. Owens is the Department Chair for Engineering and Physical Sciences and a Professor of Geology at Tyler Junior College. She graduated from Texas A&M University.

1) When were you first licensed? Why is having a PG license important to you?

I was licensed in May of 2025. I am proud to carry a PG license because it attests to my knowledge of geology as an academic subject and in practice. As a department chair and professor, my students know that I speak from a level of expertise on the topics in our class and as a geologist, potential clients have assurance of knowing I've met established standards of knowledge.

2) Why did you pursue a career in Geoscience? What part of Geoscience interested you the most?

I pursued a career in geoscience because in college, I realized that I wanted a job that would get me outside. I grew up canoeing, and thought a field that would get me back into

rivers would be ideal. Flash forward a few years, and I found my place in fluvial geomorphology.

3) What is your favorite part of working as a geoscientist?

The field work remains my favorite part. There's nothing better than being somewhere beautiful and remote and it be part of your job! As a geology professor, my favorite part of my job is seeing students decide to major in geosciences after initially taking my class simply to fulfill a science credit. I'm proud to have sent students to SFA, Texas A&M, Angelo State University, UT Permian Basin and Texas Tech as successful geology or geoscience majors.

4) What are your hopes for the Geoscience industry in Texas?

I hope to see the geoscience industry continue to innovate to meet the needs of our changing world and its inhabitants. The students entering college now have different outlooks, goals and values than those of years past and will bring exciting viewpoints and ideas to the geoscience industry. Rather than writing them off, listen to them! My students teach me things every day.

5) Do you have any advice for someone interested in a career in Geoscience?

Start learning GIS and remote sensing analysis as soon as you can. And don't think that geoscience isn't for you because you don't fit some sort of arbitrary mold.

6) What do you do in your spare time?

I like to run, lift weights, hike, and play piano. We live on 40 acres in east Texas with five dogs and six cats, so there's always something going on.

7) What do you think is the single most important thing for the future of Geology or Geosciences in Texas?

Stay open-minded and innovative. The challenges we face today and will face tomorrow require creative solutions. Listen to the people that offer them.

Highlights from the May 9, 2025 Board Meeting

Requests For Waivers

The Board reviewed seven requests for waivers. The Board approved all seven of the requests.

Discussion

Chair Prescott discussed organization updates and Board member terms. Executive Director Truan gave a report on Operations, Staff, Program updates and the current legislative session.

Committee Chair Varhaug reported on the General Issues Committee's review, research

and discussion regarding a possible Emeritus or Retired Status, Rule Review and how to increase outreach to universities.

Licensing Specialist Katie Colby provided the licensing report, including statistics from the March 2025 ASBOG Examination.

Comments on Compliance TBPG's Continuing Education Program

All currently licensed Texas Professional Geoscientists (P.G.s) as well as Geoscientists-In-Training (G.I.T.s) have a requirement for professional development to be completed over each twelve-month period of licensure. The following information is intended to provide a brief overview of TBPG's professional development program and several of its more significant requirements.

The Texas Geoscience Practice Act (TGPA, or the "Act") established a continuing education statutory requirement for all Texas professional geoscientist licensees under the Texas Occupations Code and is a program administered by the Texas Board of Professional Geoscientists (TBPG).

Details of TBPG's Continuing Education Program (CEP) are available online at TBPG's website (https://tbpg.state.tx.us/rules/) with specific annual licensee continuing education requirements located in 22 Texas Administrative Code §851.32.

The following are several relevant items regarding the continuing education requirements found in TBPG Rule §851.32:

• Meeting CEP requirements is a condition of license renewal.

• All licensed P.Gs. are required to complete a minimum of 15 continuing education hours annually; G.I.Ts. have a minimum annual requirement of 8 hours of continuing education. This includes a minimum of one hour in professional ethics, roles and responsibilities of Professional Geoscientists, or review of the TGPA and TBPG rules.

• A maximum of 30 PDHs may be carried forward into a licensee's subsequent review periods. This does not include the annual ethics training requirement which must be completed annually.

• PDHs may be earned in a variety of manners as listed in TBPG Rule \$851.32 (f)(1) – (10) but must be relevant to the practice of a discipline of geoscience

• It is the responsibility of each licensee to use their best judgement to determine if a claimed PDHs meet the CEP requirements (TBPG Board staff do not pre-approve or endorse any CEP activity).

• Licensees are responsible for maintaining adequate records used to support all claimed PDHs for a period of three years.

The preceding bullets are intended to highlight several major points regarding CEP requirements and issues that TBPG Compliance routinely sees when conducting monthly CE audits of individual Texas license holders.

A reminder for those in Soil Science!

The Council of Soil Science Examiners administers the Soil Science examinations four times a year. These windows are the only times that Candidates can sit for the

Fundamentals or Practice of Soil Science examinations.


